2) E-VOTING:

2.1 Agency:

The Company appointed Central Depository Services (India) Limited ("CDSL") as the authorized e-Voting agency for providing the e-voting platform, i.e, remote e -voting as well as e - voting at the Meeting.

2.2 Attendance & Voting

A combined total of 133 Equity Shareholders voted on the resolution by way of remote e voting as well as e voting at the Meeting. Out of the said 133 Equity Shareholders, 103 Equity Shareholders voted through remote e voting and 30 Equity Shareholders voted at the Meeting through e voting.
