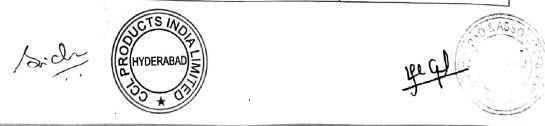

#### I submit my report as under:

- 1. The compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder and the Circulars issued by the MCA / SEBI, if any, for conducting postal ballot through electronic voting process, in respect of the business item as laid in the notice of the postal ballot dated August 21, 2023 is the responsibility of the management. My responsibility as a Scrutinizer is to ensure that the voting process during the period specified in the notice is conducted in a fair and transparent manner and to provide Scrutinizer's Report on the total votes cast in favour or against, if any, to the Chairman, on the proposed resolution, based on the report generated from the e-voting system provided by Central Depository (India) Limited (CDSL), the Agency authorized under the Rules and engaged by the Company to provide e-voting facility.
- 2. The remote e-voting period commenced on Thursday, August 31, 2023 (9:00 AM IST) and ended on Friday, September 29, 2023 (5:00 PM IST).

- 4.
