I submit my report as under:

1. The compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder and the Circulars issued by the MCA / SEBI, if any, for conducting postal ballot through electronic voting process, in respect of the business item as laid in the notice of the postal ballot dated August 21, 2023 is the responsibility of the management. My responsibility as a Scrutinizer is to ensure that the voting process during the period specified in the notice is conducted in a fair and transparent manner and to provide Scrutinizer's Report on the total votes cast in favour or against, if any, to the Chairman, on the proposed resolution, based on the report generated from the e-voting system provided by Central Depository (India) Limited (CDSL), the Agency authorized under the Rules and engaged by the Company to provide e-voting facility.
2. The remote e-voting period commenced on Thursday, August 31, 2023 (9:00 AM IST) and ended on Friday, September 29, 2023 (5:00 PM IST).
3. The notices of Postal Ballot along with the e-voting instructions were sent by electronic mode (e-mail) to those members whose email addresses were registered with the Company / Depository Participants / Depositories pursuant to General Circular No. 11/2022 dated 28th December, 2022 read with General Circulars No. 14/2020 dated 8th April, 2020 and 17/2020 dated 13th April, 2020, and other General Circulars issued by the Ministry of Corporate Affairs ("MCA") and the Circulars issued by SEBI. I have been informed that physical copies of the Postal Ballot Notice, postal ballot forms and pre-paid business reply envelopes were not being sent to members in view of the relaxation / exemption provided by the said circulars.
4. The Company Issued Newspaper advertisement on August 30, 2023, in Financial Express (English Newspaper) and Andhra Prabha (Telugu – Vernacular Newspaper), in order to facilitate those Members, who had either not registered their e-mail address or having registered the email address did not cast their vote, to participate in the e-voting.
5. The voting rights were reckoned as on Thursday, August 24, 2023, being the Cut-off date for the purpose of deciding the voting entitlement of members.

After closure of remote e-voting period specified in the Notice of the postal ballot, the votes cast through e-voting were unblocked and downloaded from the e-voting website of Central Depository (India) Limited ("CDSL") in the presence of two witnesses, not in the employment of the Company. The e-voting data/results downloaded from the e-voting system of CDSL were scrutinized and reviewed, the votes were counted and the results were prepared.
